Specifications for 3/4 ton truck, 4x2

1. **ENGINE:** Gas engine, 2500 HD or F-250 minimum, minimum 6.0L or approved equivalent.
2. **TRANSMISSION:** Automatic overdrive.
3. **AXLES:** Standard axle ratio for specified engine/transmission combination.
4. **PERFORMANCE ITEMS:** Standard instrumentation; power steering
5. **COMFORT ITEMS:** Air conditioning; all glass tinted; AM-FM radio.
6. **SAFETY ITEMS:** 4-wheel anti-lock brake system; power windows and door locks; dual outside mirrors: daytime running lights; air bags, driver and passenger.
